## APPLICABILITY

All Sailors, Active Members and Volunteers involved with sailing at Manly 16ft Skiff Group clubs, Manly 16ft Skiff Club and St George Sailing Club. For the purpose of this document these clubs shall be referred to as *"the Club"*.

# SAILING BY-LAWS


## 1.0 ORGANISATION

### 1.1 MANAGEMENT

Sailing at the Club is governed by the Club’s Constitution, Sailing By-Laws, Sailing Instructions, policies and manuals.

The business and general affairs of the Club, including all financial matters and the rights and privileges of members, are solely under the management of the Board of Directors in accordance with the Club’s Constitution.

The reporting structure for the administration of sailing is outlined in the diagram below.






## SAILING BY-LAWS

### 2.0 DOCUMENTATION

#### 2.1 STRUCTURE

The diagram below indicates the structure of documents governing the management of sailing at the Club



#### 2.2 SAILING BY-LAWS

This document is the Sailing By-Laws of the Club. It is administered by the respective Sailing Committees at each venue and published under the provisions of the Club's Constitution. All other documents that govern sailing at the Club are published and approved in accordance with the procedures and guidelines outlined in the Sailing By-Laws.

#### 2.3 SAILING INSTRUCTIONS

Sailing Instructions for all classes are prepared by the Sailing and Junior Committees at each respective venue of the Club, for approval in accordance with rule 2.5 of these By-Laws.

#### 2.4 POLICY DOCUMENT AND MANUALS

The Board of Directors may from time to time produce policy documents and manuals. The Sailing Committee may from time to time produce policies and manuals which form part of the governance of sailing. Rule 2.5 of these By-Laws outlines the approval process of such documents.

They are intended to provide additional guidance on matters relating to sailing, its management and organization and/or introduce additional requirements that do not form part of the Constitution, By-Laws, or Sailing Instructions.

#### 2.5 APPROVAL PUBLICATION AND IMPROVEMENT

The Sailing Committee encourages all sailors to be actively involved in the review and continual improvement of all documents governing sailing at the Club. Such proposed changes should be made, as appropriate, through either the Sailing Committee or Junior Committee.

All Sailing By-Laws, Sailing Instructions, policy documents and manuals must be approved by the Sailing Committee prior to publishing. These documents may only be approved, amended or cancelled by notice being given at least seven days prior to a Sailing Committee meeting and then voted upon at that meeting.

Clauses 34(b) & 34(c) of the Constitution notes the only exception to this process.

##### 2.5.1 Junior Sailing Instruction Alterations

For the Junior Division Sailing Instructions, changes that are deemed necessary to enable racing to be conducted in a safe and fair manner, may be made by the respective Race Committee. These changes must only be minor in nature, and are to be reported immediately to the Sailing Committee. The intent is to permit a change of course due to weather, or other such event, without the requirement for the Sailing Committee to meet.

### 3.0 SAILING COMMITTEE

#### 3.1 DUTIES AND FUNCTION

##### 3.1.1 Composition

The Sailing Committee shall be those members and officials elected in accordance with Rule 37 of the Club Constitution at each of the Club venues respectively.

##### 3.1.2 Duties

It shall be the duty of the Sailing Committee to carry out the objects of the Club with regard to sailing as laid down in the Club's Constitution, with the powers set out therein.

The Sailing Committee will review and recommend to the Board of Directors, if it deems appropriate, any alterations, deletions or additions recommended by the Junior Committee to these Sailing By-Laws, policy documents or manuals relevant to the Junior division.

##### 3.1.3 Meetings

All matters relevant to sailing within the Club shall be conducted by the Sailing Committee who shall hold meetings approximately every four weeks during the sailing season and at other times when necessary.

##### 3.1.4 Meeting Attendance

A nominated representative from each 16ft and 13ft Skiff registered with the Club will be required to attend at least two-thirds (2/3) of all scheduled Sailing Meetings including the Annual General Sailing Meeting (which may be held outside the sailing season) from the date of the skiff's registration, held in the sailing season, or else the 13ft skiff or 16ft skiff shall forfeit 50% of any prize money won throughout the season. Any skiff that is deemed to be not eligible for prizemoney by ways of a stimulus funding package or any other reason as determined by the Board of Directors will be required to self-fund the 50% penalty. This will be payable by 30 April each year.

If, however, a nominated representative is also a member of the Board of Directors, his/her attendance at the Board Meetings held during the sailing season shall be counted to the two-thirds (2/3) requirement for meeting attendance. 16ft Skiffs competing in the annual Old buffers day and Juniors Swap day will be awarded one meeting credit per race. 13ft skiffs will be awarded one meeting credit if they compete in the Juniors Swap Day.

For the purposes of meeting attendance, a nominated representative will be anyone listed as owner, skipper, or crew on the 16ft or 13ft skiff registration form for that season. Additional nominated representatives, for meeting attendance purposes only, may be added or removed by notifying the Race Secretary in writing (postal or electronically). One member can only act as a nominated representative for one skiff at any one time.

Additionally, at least one representative from each registered senior Class with the Club will be required to attend at least 80% of all scheduled Sailing Meetings including the Annual General Sailing Meeting (which may be held outside the sailing season) held in the sailing season

##### 3.1.5 Voting

On matters of policy and suggestions to the Board of Directors on finance, only Sailing Committee members may vote. Sailing Committee members are entitled to have one (1) vote only.

Sailing Meetings may be attended by all members, including Associate and Junior members, who may debate any matter but only Sailing Committee members, in accordance with Clause 37 & 37A of the Club's Constitution, are entitled to vote at any Sailing Committee meeting, including the Annual General Sailing Meeting. For the purposes of this voting right, a nominated representative of a 16ft or 13ft skiff on the Club's register shall be defined as being a member listed as either owner, skipper, or crew on the 16ft or 13ft skiff registration form lodged and accepted for that season.

For the avoidance of doubt, at any eligible vote, each registered 16ft and 13ft skiff may cast only one vote regardless of the number of nominated representatives from the same skiff that may be in attendance at voting time. For the purposes of voting, a 16ft or 13ft skiff registration shall be valid from the date it is lodged and accepted through to 31st August after the end of the relevant season, or when a new registration is lodged and accepted for the same 16ft or 13ft skiff, whichever is earlier.



## SAILING BY-LAWS

### 3.1.6 Proxies

Proxies and Proxy voting are not permitted at any meeting of the Club.

### 3.1.7 Special Sailing Meetings

A Special Sailing Committee Meeting may be called:

- a) on race days by the Commodore (or their representative) or Race Secretary verbally or electronically notifying at least one nominated crew member of each skiff proposing to sail on that day at least 30 minutes before the meeting. In such a case, 50% representation of the boats proposing to sail shall form a quorum;
- b) by the Race Secretary or Commodore giving 7 days notice in writing either by postal or electronically to each Sailing Committee member of such meeting; or
- c) by the Race Secretary or Commodore upon requisition by ten Active members of the Club. On receipt of such requisition, the Race Secretary shall cause a meeting to be convened within fourteen (14) days. At least seven (7) days written notice either by postal or electronically of such meeting shall be given to each Active member of the Club.

### 3.1.8 Quorum

There shall be eight (8) Sailing Committee members present to form a quorum for an ordinary sailing committee meeting. For special committee meetings, except a meeting convened in accordance with Rule [3.1.7 \(a\) and \(c\)](#) of these By-Laws, twelve (12) shall be the quorum.

### 3.1.9 Certain matters to be referred to the Board of Directors

The Sailing Committee must refer any sailing matter involving expenditure of Club funds, Constitutional matters or corporate governance to the Board of Directors.

The Sailing Committee may make recommendations or suggestions to the Board of Directors in regard to financial matters relevant to any of the Club's sailing activities.

#### 5 **General Business**

### 3.1.11 Race Committee

At the beginning of each season the Sailing Committee shall appoint a panel of six persons to constitute a Race Committee. The following Sailing Committee positions shall be ex-officio members – Commodore, Vice Commodore, and Starter. The remaining three members shall be elected by the Sailing Committee. In their absence, the Commodore may appoint a representative to the Race Committee.

The Race Committee shall be responsible for the conduct of all Club races in accordance with the Racing Rules of Sailing and the Club's Sailing By-Laws and Sailing Instructions.

### 3.1.12 Protest Committee

At the beginning of each season, the Sailing Committee shall elect a panel of five persons of whom any three or more may sit as a Protest Committee. In the absence of the required number of persons of the Protest Committee not being available, the Commodore or in his absence the Vice Commodore, may call on other persons to sit on the Protest Committee.

### 3.1.13 Boat and Sail Measurers

The Boat & Sail Measurers are to measure and record a serial number for each boat and sail used or to be used in Club races. Serial numbers are available from the Race Secretary upon application by a Club measurer, in a format as specified by the 16ft Skiff class rules.

The appropriate NSW 16ft Skiff Association approved form shall be completed for each measurement or inspection. Each measurement certificate shall then be presented to the following sailing meeting for formal approval. Sails measured and stamped by another club of the NSW 16ft Skiff Association need not be re-measured but must be sighted by this Club's Boat and Sail Measurer and serially stamped and recorded.

The Race Secretary will maintain a register of allocated serial numbers which will be linked to completed measurement forms on their return by club measurers. A copy of all measurement forms is to be retained on the Club premises in either electronic or hard copy form.

### 3.1.14 NSW 16ft Skiff Association Meetings

The Sailing Committee shall ensure, where practicable, that the Club is represented at all scheduled meetings of the NSW 16ft Skiff Association.

### 4.0 JUNIOR DIVISION ADMINISTRATION

The Junior Division is administered by its own Committee, as detailed in paragraph 4.1 under the control of the Club's Sailing Committee.

### 4.1 JUNIOR COMMITTEE

#### 4.1.1 Organisation and Conduct

It shall be the duty of the Junior Committee to manage the conduct of junior sailing at the club in accordance with Club's Constitution, Sailing By-Laws, Sailing Instructions, policies, manuals

The Junior Committee shall report to the Club's Sailing Committee.

The Junior Committee may not alter, amend or cancel these Sailing By-Laws, Club policy documents or manuals or Sailing Instructions or any other rules. It may, however, recommend changes to all the above mentioned documents, by way of a recommendation in writing to the Club's Sailing Committee.

Rule 2.5.1 of these by-Laws provides special provision for alterations to the Junior Division Sailing Instructions by the Junior Committee.

### 4.2 COMPOSITION

The Junior Committee shall be those members and officials elected at the Junior Division Annual General Meeting and shall consist of the following positions:

- a) Committee Chairperson
- b) Deputy Chairperson
- c) Secretary
- d) Delegate to Sailing Committee (2)
- e) Race Committee (Committee Chairperson, Starter + 3)
- f) Flying 11 Starting Team (3) + Race Officer
- g) Flying 11 Race Results Co-ordinators (2)
- h) MJ Starting Team (3) + Race Officer
- i) MJ Race Results Co-ordinators (2)
- j) Handicappers (3)
- k) Boat and Sail Measurer
- l) Assistant Boat and Sail Measurers (2)
- m) Delegate to the NSW Flying 11 Association
- n) Delegate to the NSW Manly Junior Association
- o) Boatshed Committee (1)
- p) A Nominated Representative of each Flying 11 and Manly Junior on the Club register
- q) Rescue Boat Operators (10)
- r) Learn to Sail liaison officer (2)
- s) MJ Deck Captain (1)
- t) F11 Deck Captain (1)
- u) Finance Officer (1)
- v) Register (1)

If any of these positions are not filled at the Annual General Meeting, then nominations for vacant positions can be taken and approved at any subsequent Meeting of the Junior Committee.



## SAILING BY-LAWS

### 4.2.2 Meetings

- a) All matters relevant to sailing within the Junior Division shall be managed by the Junior Committee, who shall hold meetings approximately once per month during the sailing season and at other times when necessary.
- b) A representative from each boat registered with the Club will be required to attend at least two-thirds of all scheduled Junior Committee Meetings held in the sailing season after the date of registration of the boat.

### 4.2.3 Voting

Each person, regardless of the number of positions held, is entitled to one (1) vote at Junior Committee Meetings.

Junior Committee Meetings may be attended by all members, including Associate and Junior members, who may debate any matter but only elected Junior Committee members as described at paragraph 4.2 are entitled to vote.

### 4.2.4 Special Committee Meetings

A Special Junior Committee Meeting may be called:-

- a) on race days by the Chairperson or Secretary verbally notifying each Junior Committee Member present at least 30 minutes before the meeting. In such a case, 50% representation of the boats proposing to sail shall form a quorum;
- b) by the Junior Secretary giving seven (7) days notice in writing either by postal or electronically to each Junior Committee member of such meeting; or
- c) by the Commodore in accordance with time frames and quorum requirement in clause (a) and (b) above.

### 4.2.5 Quorum

There shall be Nine (9) Committee members present to form a quorum for a Junior Committee meeting.

  - Protest Committee
  - Flying 11 Association Delegate
  - MJ Association Delegate

  - Training Representative
- e) General Business

### 4.2.7 Junior Race Committee

At the beginning of each season the Junior Committee shall appoint a panel of five persons to constitute a Race Committee. The following Junior Committee positions shall be ex-officio members – Junior Chairperson, and Starter. The remaining three members shall be elected by the Junior Committee.

The Junior Race Committee shall be responsible for the conduct off all Club races in accordance with the Racing Rules of Sailing and the Club's Sailing By-Laws and Junior Division Sailing Instructions.

### **4.2.8 Junior Protest Committee**

The Race Committee Chairperson may call for a protest committee to be formed as required.

### **4.2.9 Boat & Sail Measurers**

The Boat and Sail Measurers will be responsible for measuring boats, foils, sails and spars in accordance with current Flying 11 and MJ Association class rules and restrictions.

### **4.2.10 Junior Team Managers**

The Junior Committee may elect a member of the club to the position of Junior Team Manager, to attend external regattas as required. The Junior Team Manger shall report to the Junior Committee.



## SAILING BY-LAWS

### 5.0 GENERAL RULES

#### 5.1 BREACHES OF SAILING BY-LAWS

The Sailing Committee may disqualify any boat or take action against an owner, crew member, volunteer, coach, support person, or member for a breach of any Sailing By-Laws, Sailing Instructions or any other rules that govern sailing events at the Club.

#### 5.2 SAILING SEASON

The sailing season will commence not before the first Saturday in September in each year and conclude by the end of April in the following year.

#### 5.3 TROPHIES AND TRADITIONAL ALLOCATION

Where a Traditional Allocation relates to a specific race or event, that event will be included in the sailing program of events for the respective division.

### 5.4 STORAGE OF BOATS

No skiff or Junior Class of boat shall be placed in any storage area owned or leased by the Club without first complying with the prescriptions of the Boat Shed Storage Policy.

### 5.5 BOAT SHED RIGGING SPACE

#### *16ft and 13ft Skiff Divisions*

On normal race days when both 16 and 13ft skiff fleets are competing, 13ft skiffs are not to rig or unrig on the boatshed ramp area designated for 16ft skiffs. Any 13ft skiff contravening the intent of this bylaw will be disqualified from the day's race or the next race that they finish without recourse to Protest under RRS 60.

### 5.6 WITHDRAWAL FROM SAILING

Any owner withdrawing a skiff or boat from competing at the club or who sells his skiff or junior class boat shall notify in writing (postal or electronically), the Sailing Office<sup>1</sup> within seven (7) days.

### 5.7 NEW SKIFFS OR JUNIOR CLASS BOATS

Entry for new boats is permitted, an owner shall:

- a) before entering a skiff or junior class of boat into Club races or subsequently before each season, complete a On line Boat Registration form and submit all information as required by the Club, Sailing By-Laws and Sailing Instructions.
- b) before racing, submit his/her boat and gear to the Club Measurer for measurement if required.

### 5.8 CREW TO BE FINANCIAL

In all races (except social races), crews shall be financial, Active, Associate or Junior members, except persons to whom Rule [5.9 'Visitors'](#) of these By-Laws apply.

### 5.9 VISITORS

No visitor to the Club shall participate in more than two (2) races (other than social races) without making a bona fide application for Active, Associate or Junior membership, as appropriate.

### 5.10 INTER-CLUB ENTRIES

An owner wishing to enter any race for which an entry form (written or electronic) has to be completed, shall lodge such entry form with the Race Secretary, Sailing Office or the relevant Class Association prior to the closing of entries in accordance with the entry form.

A skiff or boat owner shall be liable to the Club for any entry fees paid on his/her behalf.

## SAILING BY-LAWS

---

### 5.11 TRAVELLING ASSISTANCE FUND

The Board of Directors may approve each season, funding to assist skiffs or boats to participate in Interclub regattas or Australian Championships. The funding will be allocated to the boat owner and where practical is to be evenly distributed amongst all crew members to offset travelling costs.

For the purposes of the above paragraph and “owner” shall be;

- a) the person who purports to have the major financial interest in a skiff or boat and holds themselves out to be the owner of the skiff or boat, or
- b) if more than one person purports to have a major financial interest in the skiff or boat, all those persons equally and severally. Sufficient evidence to purport major financial interest should be available.
