- START WAS MADE (WIND SHIFT NOT CONSIDERED RELEVANT TO THIS REQUEST FOR REDRESS)
- RACE SHORTENED
- ABANDONMENT SIGNAL MADE POST 1ST BOAT FINISHING (NOT CLEAR TO ALL COMPETITORS & WITHOUT CLASS FLAGS) - POSSIBLE UNDER 32.1
- TTR PREPARED TO RETURN TO SHORE, HAD BEEN CATCHING UP AT TIME CEASED RACING
- BOATS SUBSEQUENTLY TOLD THEY WERE STILL RACING - TTR RE-ENGAGED WITH RACING
- CLAIMS OF ILLEGAL PRODUSSION NOT CONSIDERED AS NOT A PROTEST AGAINST OTHER BOATS. PROTEST COMMITTEE UNABLE TO DEAL WITH UNDER 60.2

Conclusion & Rules:

- SIGNIFICANT CONFUSION DUE TO RACE COMMITTEE FLYING ABANDONMENT WITH SOUND SIGNALS - TTR NOT WITHIN A DISTANCE TO SEE FLAG THAT WERE HANGING DUE TO LACK OF BREEZE. RULE 32.1
- TTR STOPPED RACING - SIGNALS ACROSS MULTIPLE FLEETS EVIDENCED
